TIMEFRAMES

The leadtime for indent jobs is specified on the quotation. Leadtimes on indent jobs are an estimate only and Leopard cannot be held responsible for any delays which occur outside of our control.

Our standard lead time for local branded jobs is 10 working days. Give us a call if you need our *Fast Turnaround Service* for tight deadlines. This extra priority of fast turnaround may incur up to \$50.00 surcharge.

SAMPLES

Samples of most products are available at request. Samples are loaned for 30 days and invoiced if not returned.

If we do not currently have a sample here of a product which we have sourced for you, we can bring one in from the offshore factory. There may be a charge for this sample if you do not go ahead with the order.

APPROVALS

We always send you an artwork proof/visual for your approval prior to branding. For indent jobs a pre-production sample may also be provided, which may incur a small extra cost. Our order confirmation form (including business terms) also must be signed and returned to us before we can proceed with any job.

ARTWORK REQUIREMENTS

Your logo needs to be emailed through to artwork@leopardpromo.co.nz for branding. We require logos in *editable vectored art files*, preferably in an *.eps format*. All text should be converted to paths/curves. The person who designed the logo should be able to supply the correct file type, but if not we can redraw the logo to the required quality level. This will incur an artwork design charge. If you have questions regarding your artwork files, please feel free to give us a call, or we are more than happy to speak with the designer of the logo with regards to our requirements.

BUSINESS TERMS

Payment for local jobs is due strictly on 20th month following invoice. Indent jobs require a 30% deposit with order and balance of payment is to follow 7 days after delivery of goods.

While every effort will be made to deliver the exact quantity ordered Leopard Promotions reserves the right to deliver the amount ordered plus or minus 5%, which the buyer will accept and pay for. Since the goods are custom branded for you, the order is not subject to cancellation or reduction after branding.

Ownership of goods will not pass to the buyer until payment is received in full.

Approval of any designs, logos, artwork etc prepared by Leopard Promotions in order to fulfil the order is the sole responsibility of the buyer and Leopard Promotions accepts no responsibility or liability for any errors or omissions in said designs, logos artwork etc once approved by the buyer.

Ownership of any intellectual property created to fulfil the order (including but not limited to patents, designs, copyright and trade marks) remains vested in Leopard Promotions. This notwithstanding Leopard makes no representations as to the ability of the buyer to use or sell the goods supplied and the buyer agrees to indemnify and hold harmless Leopard Promotions against any claim, loss or expense which Leopard Promotions might suffer in fulfilling the order for the buyer including, but not limited to, infringement or alleged infringement of any patent, trade mark, registered design, copyright or common law right (or foreign equivalents). Where the buyer is to supply logos, artwork etc to Leopard Promotions in order to fulfil the order, buyer warrants that it has sufficient right to said logos, artwork etc and agrees to indemnify Leopard Promotions as aforesaid."
